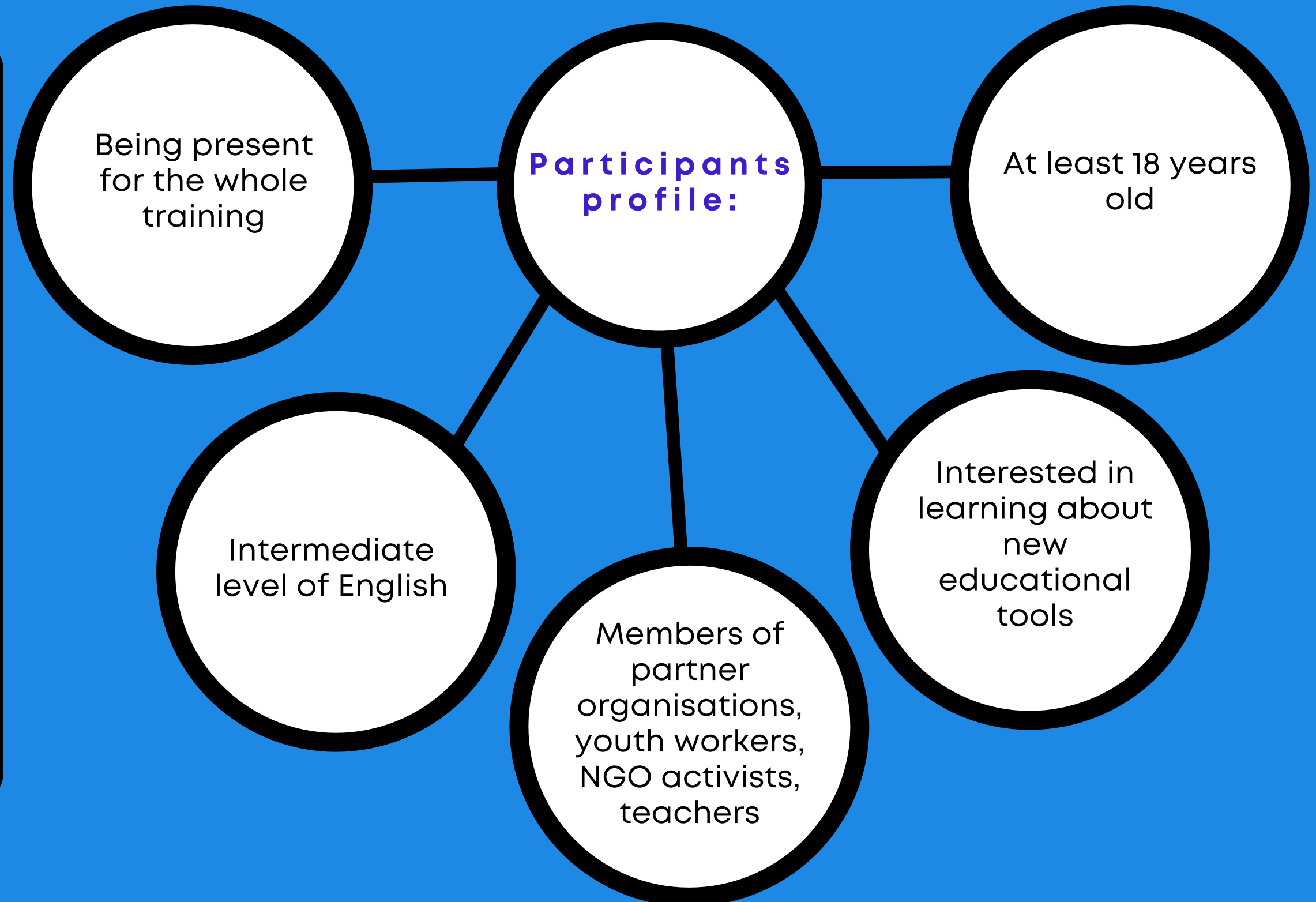
ABOUT THE PROJECT

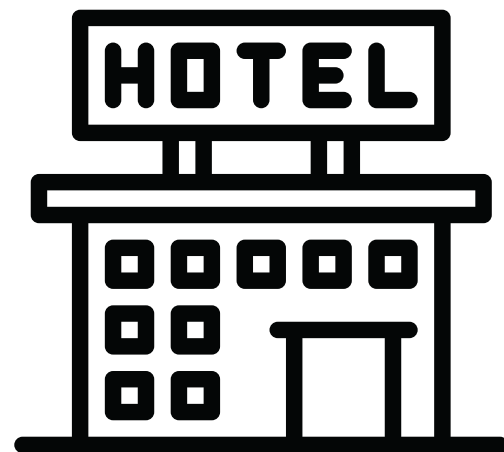

PRACTICALITIES

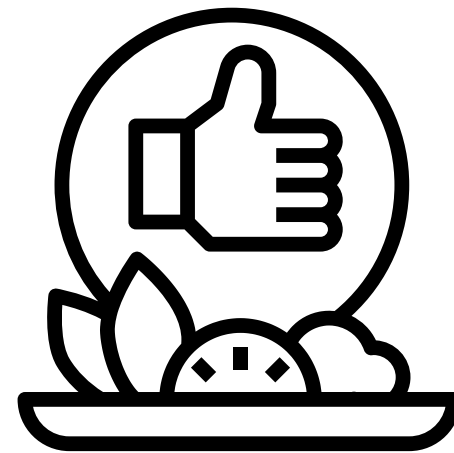

We kindly ask you to inform us in advance by email about any special needs or assistance you may need



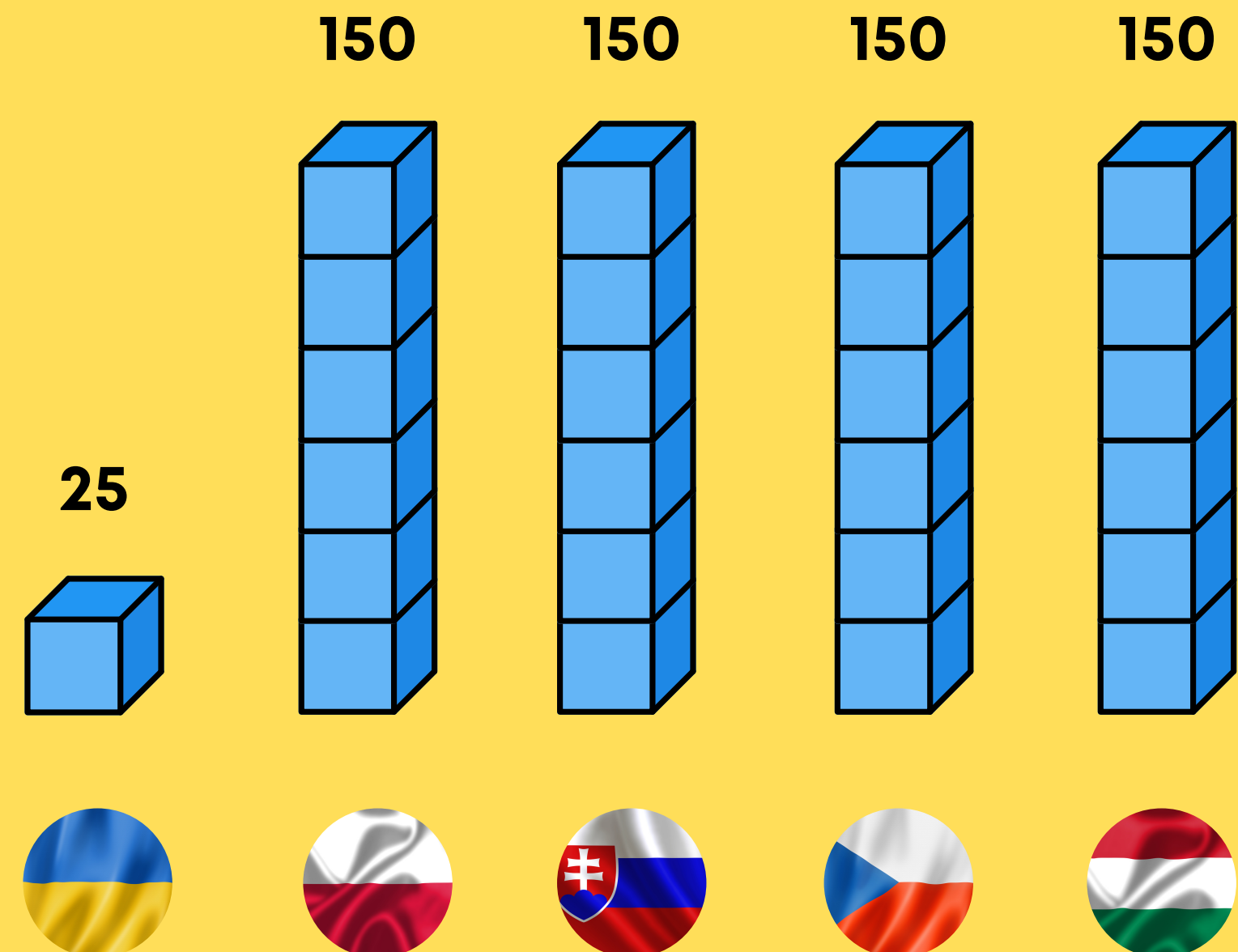
TRAVEL

As for the middle of March 2021 to enter Ukraine without being quarantined you need to have a negative Covid-19 test made in the last 48 h. The requirement may change, so we will keep you posted in the FB group (link in the info pack). The cost of the test is going to be reimbursed within travel limits. 15 and 25 of May are travel days.

Kyiv is a big city with two international Airports (Zhuliany and Boryspil) both of them well connected by public transportation.

The participant should bring all tickets/invoices and actively participate in the Activity to receive reimbursement. The reimbursement will be done within 3 weeks of the project main activity by bank transfer if all the relevant documents are attached.

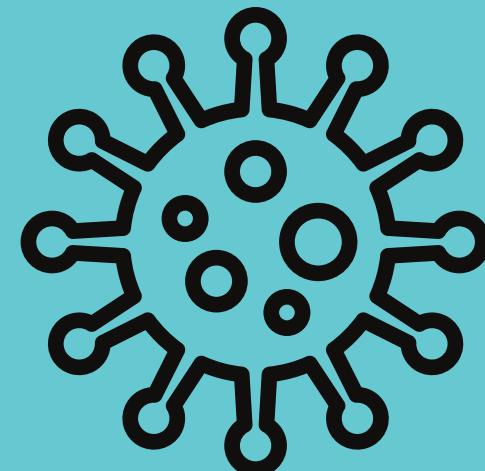
During the Training course we will follow the recommendation of WHO and Ukrainian National Authorities.

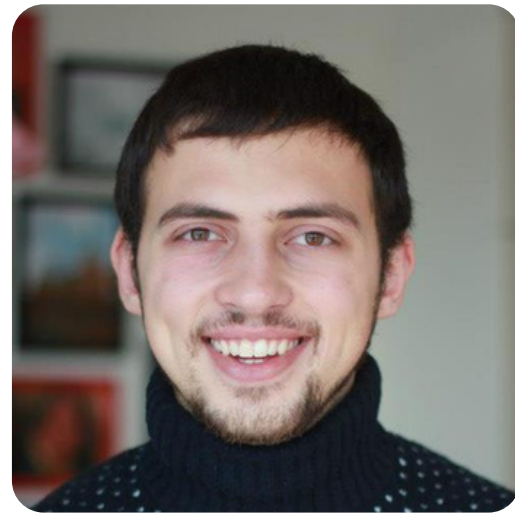
