


About the project

The main aim of the proposed project is to enhance knowledge and understanding of human rights in order to foster tolerance, respect, solidarity and responsibility of the participating youth workers, so that they in turn can "spread the word".

A comprehensive education on human rights and on the mechanisms that protect individual but also collective rights, as well as knowledge of the concomitant responsibilities and duties will be provided with the purpose of enabling youth workers & ultimately, young people to promote, defend and apply human rights in daily life. The project will convey fundamental principles, while explaining their interdependence, indivisibility and universality. Emphasis will be given on the benefits of multicultural societies, on European Citizenship and active participation.





Objectives

• Deepen youth workers' awareness about human rights issues, especially about the ones affecting young people (e.g. violence, and exclusion)

• Equip youth workers with knowledge, skills and attitudes that support their positive contributions to society, based

on respect, equality, justice and solidarity

 Engage participants in a dialogue about how human rights laws and principles can be translated into their own social, economic, cultural and political reality, using participatory learning methods that aim to sharpen critical analysis

 Train youth workers' mentoring skills and capacity in acting as multipliers in their daily work with youth

 Establish & strengthen cross-border partnerships & future common projects and enhance their multiplier effect and impact



Participants



The training course is open for educators - trainers, teachers, facilitators, youth workers, youth leaders. Volunteers or active members in their local communities, who want to better understand digitally based social challenges and successful ways to deal with them can also participate.

Participants should be:

- Fluent in English
- 21-45 y.o.
- Priority will be given to people with fewer opportunities

Every participant should participate in every phase of the project (before, during & after), and in the whole duration of the TC, and be motivated to explore the topic!!

Selected participants are in charge of dissemination and visibility activities online and offline.

Main mobility

This program is subdivided in 4 "chapters" of activities:

- 1.**Teambuilding** Make participants feel comfortable with each other
- 2. **Group discussions & interactive presentations** solidify youth workers' & other participants' knowledge on specific thematics referring to the generic one of human rights
- 3. Workshops enlighten youth workers both on issues related to a project's optimal presentation & recognition, & on non-formal learning resources & tools that allow youth workers to enhance their creativity & negotiation skills
- 4. Developing novel Human Rights Education toolkit train participants how to reflect on and utilize their own learning experience to externalize and multiply their gained knowledge

Venue

For the whole time of the mobility, the participants will work and live in the "Olde Vechte Foundation". (Zeesserweg 12 7731 BG, Ommen) which is located in the Overijssel province.

This also the meeting point on the 29th of September.

Travel Conditions & Instructions

How to get there:

The best solution is to travel to Ommen via **Amsterdam Airport Schiphol** with flight.

From Airport Schiphol, you should take the train to Zwolle and then to make a change and take another train to Ommen. From Schiphol there are trains every 30mins to Zwolle and the approximate time from Schiphol Airport to Ommen is 90mins.

Please KEEP the RECEIPT that states the price after you purchase your ticket, so that we can reimburse it.

When you reach **Ommen station**, is **10 mins** walking distance and we will come to pick you up from the station.

Covid regulations:

The are no restrictions for people from countries within the EU/Schengen area but you need to fill in the <u>health declaration form</u> if you travel by airplane

Other information

Financial Conditions:

The project covers 100% of:

- Accomodation costs (hotel & 3 meals per day)
- Travel costs (up to a certain limit, according to Erasmus+ Distance calculator

Youthpass:

At the end of a project you will get Youthpass. It will confirm your participation in the project and will reflect which skills you learned during the project.

More about Youthpass you can read on the official website

Health insurance:

All participants have the responsibility to obtain the EHIC (European Health Insurance Card) which is for free. Please keep in mind, even if you have an EU Insurance card, this would not cover any travel incident. It is your own responsibility to arrange your own travel and health insurance.

!You may want to travel 1-2 days earlier & later than the Training's dates: In this case your tickets are eligible for reimbursement but you will have to cover your accommodation expenses yourself for the extra days!

Reimbursement

To get your reimbursement we compulsory require:

- 1. E-Ticket/receipt/invoice of your booking of the flights and generally every means of transport that you will use from your home until reaching the venue and for your return.
- 2. Boarding passes/travel tickets in **original format**, used to travel to/from the venue (Amsterdam). In case your airline does not offer the possibility of online check in, and you have your boarding passes printed at the airport, we need the original boarding passes (no photos or scans).
- 3. PCR/antigenic tests for Covid19 prevention if it is necessary in the next months.
- 4. ATTENTION: it is compulsory to have the Green Digital Passport for our project. Please, also check the validity of your vaccination status and the related docs.
- 5. Please, bear in mind that we cannot reimburse your travel costs unless we receive the mentioned documentation. To have your expenses fully reimbursed, please book 'two-way' tickets(incl. bus/train etc.).
- 6. Dates must be corresponding to the project dates of arrival and departure.

Reimbursement Rules

- The participants (or the partners) are expected to purchase their own travel tickets, and the actual costs will be reimbursed by yEUth after the project through bank transfer, on the basis of the relevant justifying documents handed in to yEUth.
- Transport cost coverage and reimbursement includes transport from and to the airport in Amsterdam, in addition to the transportation from your city of residence to the nearest airport within your country and back.
- PCR/antigenic tests for Covid19 prevention if it is necessary in the next months.
- ATTENTION: it is compulsory to have the Green Digital Passport for our project. Please, also check the validity of your vaccination status and the related docs.

To get your reimbursement we compulsory require:

The original invoice of the flight showing:

- 1. the name of the participant
- 2. the dates and times of travel and
- 3. the amount paid

Reimbursement Rules

To get your reimbursement we compulsory require:

Boarding passes.

It is essential that the boarding are electronic and sent to us by email Electronic boarding passes are the documents received AFTER on-line check in, which have a barcode (not the booking confirmation mails). On the occasion your airline does not offer the possibility of online check in, and you have your boarding passes printed at the airport, we need the original boarding passes (no photos or scans).

Electronic or printed bus/train tickets from and to the Airport of your country of origin (including transportation to the city, where the Airport is located, if applicable). The receipts of the train/metro/bus tickets from and to the Airport in the Netherlands (not just the ticket itself)

Reimbursements are made according to the travel documents submitted: No payment will be made without proof of your expenses!

No reimbursement can be made unless we have all boarding passes, flight invoices & all other required documents for all participants of each group
